Process

1. Application period is between **February 12, 2021 and March 5, 2021**. All applications must be received during this period for consideration.
2. The Town (Planning, Engineering, DPW, Police, Fire, Manager, Design Review Committee and Disability Access Committee) will review all applications at once to coordinate sites.
3. April 1, 2021 start date for outdoor dining/retail establishments.

General Guidelines

1. Heavy separation
 - Large planters with live vegetation are most preferred
 - Water-filled and Jersey barriers may be used in conjunction with coordinated artwork.
 - It is anticipated that both heavy and light separation will be used at each site. Each type of separation (heavy and light) shall be uniform in its application (color, size, material etc).
 - Using multiple types of heavy separation or multiple types of light separation will not be allowed.
2. Lighting should be incorporated on or above the heavy separation

Checklist for Application

- Signed Application Form
- Proof of Business Ownership
- If premises is leased, copy of lease or written permission by the building owner
- Permit to operate a food establishment issued by the Winchester Board of Health
- Professionally drawn plan showing all tables and chairs (with at least 6' distance between all individuals at other tables) and all supporting documentation required in order to make a decision as to the license and shall also include a plan for outdoor lighting if any is proposed.
- Location, size, and specifications of all **heavy separation** (large planters, jersey barriers, water-filled barriers, concrete barriers, filled barrels, flexible posts and delineators) and/or **light separation** (small planters, traffic barrels, sawhorses, movable parade barricades, or A-frames)
- Photos of location where outdoor seating will be placed
- Application fee (waived in calendar year 2021)
- Certificate of Insurance naming the Town as additionally insured
- Compliance with any other physical distancing requirements under State laws, orders, or guidelines
